ORDINANCE NO. 2026-

TOWNSHIP OF MIDDLETOWN

ORDINANCE AUTHORIZING ACCEPTANCE
OF DEED OF ROADWAY DEDICATION UPON
BLOCK 559, LOTS 1.01 AND 1.02 (MURPHY ROAD)

WHEREAS, on August 9, 2025, pursuant to Planning Board Resolution No. 2025-100, the Township of Middletown (the “**Township**”) Planning Board granted minor subdivision approval with certain variances to Winsolar Orca 2, LLC on the condition that it provide a Deed of Roadway Dedication along Murphy Road where the two lots are located consisting of approximately 3,634 square feet in total area; and

WHEREAS, N.J.S.A. 40A:12-4(a) authorizes municipalities to acquire interests in real property, including easements and rights of way, and N.J.S.A. 40A:12-5(a) requires the acquisition of such interests be authorized by ordinance; and

WHEREAS, the Planning Board Attorney, Township Attorney and Engineer have reviewed the proposed form of Deed of Roadway Dedication and the accompanying property description prepared by Robert H. Morris, PLS dated December 12, 2024, and recommend acceptance of the same.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Middletown, County of Monmouth, State of New Jersey, as follows:

1. The findings set forth in the foregoing recitals are hereby incorporated as if fully restated herein.
2. The Mayor and Township Clerk are hereby authorized to accept the Deed of Road Dedication attached hereto as **Exhibit A** subject to the final review and approval of the Township Attorney and Township Engineer.
3. The Mayor, Township Clerk, Township Attorney, and Township Administrator are hereby authorized and directed to execute and file all such documents and undertake all actions as may be reasonably necessary to effectuate the acquisition of the easements authorized herein.

4. All ordinances and resolutions, and parts of ordinances and resolutions, which are inconsistent with provisions of this ordinance shall be, and are hereby, repealed to the extent of any such inconsistency.
5. This Ordinance shall take effect upon passage and publication in accordance with law.

WHEREAS, Winsolar Orca 2, LLC, is the owner of property known as 79 Murphy Road, designated as Block 559, Lot 1 on the Tax Map of Middletown Township, and located in the R-22 Zone; and

WHEREAS, Winsolar Orca 2, LLC is the applicant; and

WHEREAS, the applicant makes an application to the Planning Board for minor subdivision, variance and design waivers approval to subdivide a residential lot, known as Block 559, Lot 1, a 74,212 square foot lot, into two residential lots; and

WHEREAS, the applicant was represented by Henry Wolf, Esq. in connection with this subject application; and

WHEREAS, applicant seeks to create two new lots known as Lot 1.01 and Lot 1.02: and

WHEREAS, proposed Lot 1.01 will contain 29,392 square feet, is a corner lot with 200 feet of frontage along Murphy Road and 96 feet of frontage on Alimar Drive; and

WHEREAS, proposed Lot 1.02 will contain 41,186 square feet and 337.9 feet of frontage along Murphy Road and wetlands and wetlands transitional areas in the northeastern portion of the lot; and

WHEREAS, a variance is required for buildable lot area for new lot 1.02 where 15,000 square feet is required and 6,337 square feet is proposed; and

WHEREAS, the applicant received a NJDEP General Permit 6 on August 23, 2021, to fill a portion of the wetlands on proposed lot 1.02. After this portion of wetlands is filled, the buildable lot area will be 27,888 square feet and no variance will be required; and

WHEREAS, the applicant proposes to construct a single-family home on each new lot; and

WHEREAS, on December 1, 2021, applicant sought approval for a similar minor subdivision, variance and design waivers approval which was approved by the planning board and memorialized in a resolution dated January 20, 2022; and

WHEREAS, the subdivision was not perfected that that time; and

WHEREAS, the applicant acknowledges that to construct the proposed single family dwellings approvals for construction would be required; and

WHEREAS, the applicant submitted the following in connection with its application:

1. Written request for waivers prepared by Henry F. Wolff, III, dated April 25, 2025;
2. Correspondence regarding deed restrictions and covenants, prepared by Henry F. Wolff, III dated April 25, 2025;
3. NJDEP LOI Line Verification letter, dated November 20, 2020 ;
4. NJDEP Watershed and Land Management Permit, dated August 23, 2021;
5. Boundary Survey, prepared by Nelson Engineering Associates, Inc., dated March 8, 2021, last revised April 28, 2025;

6. Preliminary and Final Major Subdivision Plans, consisting of three sheets, prepared by Nelson Engineering Associates, Inc., dated December 12, 2024;
7. Minor Subdivision Plat, prepared by Nelson Engineering Associates, Inc., dated December 12, 2024;
8. Drywell Design Report, prepared by Nelson Engineering Associates, Inc., dated December 12, 2024;
9. Architectural Plans, consisting of two sheets, prepared by Matthew T. Cronin, AIA Architect, dated December 6, 2024, last revised December 12, 2024;
10. Affidavit of ownership;
11. NJ Division of Taxation and Enterprise Services filing amendment, dated January 6, 2025;
12. Signed w-9 form;
13. Verification that property taxes are current;
14. Zoning Officer Denial; and
15. Application for Development Permit.

WHEREAS, the application and plans were circulated to various agencies, commissions and offices regulated by Township Ordinance; and

WHEREAS, public notice was given in accordance with the requirements of the Municipal Land Use Law for the public hearing, and all interested parties were given an opportunity to be heard and express their opinions; and

WHEREAS, the applicant presented the testimony of Matthew Cronin, a New Jersey licensed engineer; and

WHEREAS, the applicant presented the testimony of John Taikina, a New Jersey licensed planner; and

WHEREAS, the applicant presented the testimony of Matthew Dubios, a New Jersey licensed engineer; and

WHEREAS, the applicant presented the testimony of a principal of Winsolar Orca 2, LLC; and

WHEREAS, the Board and staff reviewed the materials submitted and have carefully considered all the evidence and all the applicant's testimony, presentation of the objector and testimony of the public, if applicable; and

NOW, THEREFORE, BE IT RESOLVED, that the Planning Board of the Township of Middletown does hereby find the following facts:

1. The applicant is the owner of the subject property, designated as Block 559, Lot 1. The Property is approximately 1.7 acres (74,212 square feet). The property is in the R-22 zoning district. Single family homes are permitted in the zone district.
2. The applicant is seeking a minor subdivision approval to subdivide the 1.7 acre lot into two new lots. Proposed Lot 1.01 is approximately 29,392 square feet with 200 feet of frontage on Murphy Road and 96 feet of frontage on Alimar Drive. Proposed Lot 1.02 is approximately 41,186 square feet with 337.9 feet of frontage on Murphy Road.
3. The applicant proposes to construct a single-family dwelling on each of the new lots.
4. The following variance is required:

Buildable Lot Area Lot 1.02

Section 540-911.A.1.c. provides that the minimum buildable lot area of 15,000 square feet is required. Applicant proposes 6,337 square feet of buildable lot area for Lot 1.02. Applicant received a NJDEP General Permit 6 on August 23, 2021 to fill a portion of the wetlands of Lot 1.02. After this portion of wetlands is filled, the buildable lot area will be 27,288 square feet removing the need for a variance. **A variance is required at this time.**

5. The following design waiver is required:

Clearance of wooded areas

Section 540-651.B. provides that no more than 40% of wooded areas with the net tract area may be cleared or developed. Prior to approval, 80% of the wooded area was cleared. Applicant provided testimony regarding the difficulty in complying with design requirement. **A design waiver is required.**

6. Applicant has agreed to comply with the requirements of sections 540-645.C. (street trees) and 540-622.B.6. (trees per acre in single-family subdivisions) by planting 7 trees on Lot 1.01 and 10 trees on Lot 1.02. The plans will be amended to reflect these plantings.
7. Applicant will dedicate 3,634 square foot portion of their property along the frontage with Murphy Road to the Township.
8. Applicant has agreed to deed restrictions for Lot 1.01 and Lot 1.02 to restrict impervious coverage.
9. Applicant will provide a conservation easement for the remaining wetlands and wetlands transition areas,

10. Applicant has agreed to install new sidewalks on the frontage of the property on
Murphy Road and Alimar Drive.
11. Applicant will be installing a drywell of both lots subject to review and approval of
Township professionals.
12. Applicant will remove the existing driveway curb cut on Alimar Drive along the
frontage and provide full height curb in this location. The apron shall be restored
with lawn and any sidewalk affected by the removal and shall be replaced.
13. Applicant represented that the garages for the new dwellings will not face either
Murphy Road or Alimar Drive.
14. Applicant will comply with all applicable Township tree removal ordinances.
15. John Taikina, the applicant's planner testified that the proposed subdivision is
consistent with the established development of the neighborhood. In his opinion
subdividing the lot is in character with the neighborhood. The variance for buildable
lot area for Lot 1.02 does not create a substantial detriment to the neighborhood as
this variance will no longer exist once the wetlands are filled in per the NJDEP
General permit #6. In his opinion, the benefits of granting the variances substantially
outweighs any detriments. The planning benefits satisfy the purpose of N.J.S.A.
40:55D-2, categories c, e, g, i and j as the proposed lots provide adequate light, open
air and open space, establishes appropriate population density, and creates a desirable
visible environment.
16. The Board finds that the positive criteria has been satisfied for the variance requested.
Similarly, the negative criteria has been satisfied. The potential dwellings on Lots
1.01 and 1.02 is a better use of the land. There will be no negative impact on adjacent

properties. The subdivision of the property will provide additional housing opportunities for the community. The subdivision is a more efficient use of the land as its size appropriately accommodates 2 dwellings. The subdivision will allow for the development of homes which will be consistent with other homes in the neighborhood and create a desirable visual environment and preserve the historic nature of the neighborhood. As for the negative criteria, the variances can be granted without substantial impairment to the zone plan and zoning ordinance, and without substantial detriment to the public good.

17. The Board finds that the applicant's compliance with Section 540-651.B is impracticable and a design waiver should be granted.
18. The Board accepts the testimony and stipulations made by the applicant during the hearing, and such testimony and stipulations are part of the record and binding on the applicant.

BE IT FURTHER RESOLVED, that the Planning Board of the Township of Middletown does hereby grant minor subdivision approval with variance approval and design wavier noted above to the property owner based upon the evidence and findings contained herein subject to the conditions listed on Exhibit A attached hereto and made a part hereof.



The following conditions of approval for Application #2024-106 shall be satisfied prior to the filing of a subdivision plat, unless otherwise noted.

1. Compliance with the Township Planner's Report dated July 23, 2025.
2. Compliance with the Township Consulting Engineer's report dated July 25, 2025.

3. Approval or letter of no jurisdiction by the Monmouth County Planning Board, NJDEP and Freehold Soil shall be obtained.
4. Prior to the issuance of a building permit for Lot 1.01 and 1.02, an approval or a letter of no jurisdiction must be obtained from the Township of Middletown Sewerage Authority, or Board of Health approval for use of a septic. If feasible, applicant agrees to connect to the Township sewerage system and comply with all requirements and costs associated therewith.
5. A contribution to the Affordable Housing Trust is required prior to the issuance of a certificate of occupancy for Lot 1.01 and 1.02.
6. New lot numbering shall be subject to review and approval of the tax assessor.
7. A conservation easement for the remaining wetlands and wetlands transitional areas is required, subject to the review of Township professionals and the Planning Board attorney and acceptance by the Township.
8. Applicant shall provide sidewalks along the frontages of Murphy Road and Alimar Drive, and may repair or replace the portions of existing sidewalk. A sidewalk detail is required.
9. A public easement for the existing portions of sidewalk located on private property shall be provided and subject to the review of Township professionals, Township attorney and planning board attorney.
10. The applicant shall provide driveway apron detail for review.
11. A grading plan is required prior to the issuance of a building permit for either lot.

12. The existing curb-cut on Alimar Drive will be removed and full height curb shall be provided in this location. The apron shall be restored with lawn and any sidewalk affected by the removal and shall be replaced.
13. Dry wells will be installed on both lots, subject to review and approval by township professionals.

WHEREAS, the Township of Middletown (“**Middletown**”) issued Tax Sale Certificate No. 22-00004, relative to Block 13, Lot 26 which was recorded in the Office of the Monmouth County Clerk in Book OR-9636, Page 6600, Instrument No. 2023016333; and

WHEREAS, under Docket No. F-4539-25, the Superior Court of New Jersey entered an order foreclosing upon the subject property; and

WHEREAS, post foreclosure, pursuant to Resolution No. 26-76, Middletown authorized the transfer of the premium payment of \$7,000 pursuant to N.J.S.A. 54:5-33; and

WHEREAS, on May 8, 2026, a Consent Order Vacating the Final Judgment was entered, which in part requires Middletown to repeal Resolution No. 26-76 upon redemption.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey that it hereby repeals Resolution No. 26-76 and authorizes the transfer of the \$7,000 premium payment out of the Township’s General Fund in accordance with the Consent Order Vacating the Final Judgment.

BE IT FURTHER RESOLVED that the Tax Collector and Chief Financial Officer are hereby authorized and directed to take any and all steps reasonably necessary to effectuate the foregoing.

**RESOLUTION AUTHORIZING NEW SHARED SERVICES
AGREEMENT WITH MIDDLETOWN BOARD OF EDUCATION FOR
PROVISION OF ARMED CLASS III SPECIAL LAW ENFORCEMENT
OFFICERS AT ALL MIDDLETOWN SCHOOLS**

WHEREAS, the Uniform Shared Services and Consolidations Act, N.J.S.A. 40A:65-1 et seq. authorizes local governmental entities to enter into an agreement, among other things, for the sharing of services with boards of education; and

WHEREAS, N.J.S.A. 40A:14-146.10 establishes the position of Class III Special Law Enforcement Officer to provide security to schools in the State of New Jersey when school is in session for students and staff; and

WHEREAS, in 2024, the Township of Middletown (the “**Township**”) and the Middletown Township Board of Education (the “**Board**”) agreed to renew their August 25, 2022 Shared Services Agreement for the provision of armed police officers at each Middletown school (the “**Agreement**”) through June 30, 2026; and

WHEREAS, the parties wish to enter a new Agreement for a term covering July 1, 2026 through June 30, 2028 pursuant to new terms and conditions.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey that the Mayor is hereby authorized and directed to enter a new Shared Services Agreement with the Board covering July 1, 2026 through June 30, 2028 pursuant to the terms and conditions contained in **Exhibit A** attached hereto and made part hereof.

**RESOLUTION AUTHORIZING PROPERTY TAX RELIEF PAYMENTS

WHEREAS, on April 28, 2025, the Township of Middletown (the “Township”) adopted Ordinance No. 2025-3459 establishing its Volunteer Property Tax Relief Payment Program for eligible volunteers who are Township property taxpayers as part of the Township’s Volunteer Incentive Program; and

WHEREAS, upon eligibility determinations being made pursuant to the requirements of Ordinance No. 2025-3459, and the Township’s annual appropriation having been made in the 2026 Township budget, a certified list of eligible volunteers has been prepared for approval for payments to be made by the Township.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey, that:

1. The Chief Financial Officer is hereby authorized and directed to issue payments of \$500 to each eligible volunteer listed in **Exhibit A** attached hereto and made part hereof pursuant to the Township’s Volunteer Property Tax Relief Payment Program.
2. This Resolution shall take effect immediately upon adoption.

RESOLUTION 26-194

**TOWNSHIP OF MIDDLETOWN

**RESOLUTION OPPOSING AND SEEKING REPEAL OF RECENTLY
ENACTED STATE LAWS AFFECTING LAW ENFORCEMENT
OPERATIONS, FEDERAL-STATE COOPERATION AND PUBLIC
SAFETY**

WHEREAS, the Township of Middletown (the “**Township**”) has a fundamental responsibility to protect the health, safety, and welfare of its residents and to support law enforcement officers in the lawful execution of their duties; and

WHEREAS, the Governor recently signed legislation impacting federal-state cooperation in immigration enforcement, creating sanctuary spaces for immigrants in the country illegally and impacting law enforcement operations; and

WHEREAS, A4071/S3521 restricts certain communications and cooperation between state and local law enforcement and federal immigration authorities; and

WHEREAS, SCS for S3114 and S3216/A1743 requires law enforcement officers, including ICE agents, to reveal their facial identity during certain public interactions and to present identification before arresting or detaining an individual, which this governing body believes may interfere with law enforcement operations and raise constitutional concerns; and

WHEREAS, A4070/S3522, described as the “Privacy Protection Act,” limits the collection and sharing of certain personal information, which the Township believes may hinder law enforcement investigations and interagency coordination; and

WHEREAS, the so-called “Safe Communities Act,” or S5036, prohibits sensitive locations from assisting or participating in federal civil law enforcement, and would also prohibit enforcement on the premises of those locations including hospitals, public schools, shelters, disaster and emergency response sites, funeral homes, courthouses, and places of worship, thus creating safe spaces for criminals to hide from law enforcement; and

WHEREAS, the Township recognizes the importance of constitutional rights, due process, lawful policing, and public accountability, but also finds that public policy should not jeopardize officer safety, operational effectiveness, intergovernmental cooperation, the ability of law enforcement agencies to respond

to evolving public safety threats, or negatively impact the safety of the public at large; and

WHEREAS, the Township is concerned that restrictions affecting communication, coordination, identification practices, and information-sharing, as well as policies that prohibit law enforcement from pursuing criminals at certain locations will create uncertainty for local law enforcement agencies, complicate interactions with federal authorities, increase risks to officers operating in volatile and rapidly developing situations and give sanctuary to criminals among the very communities these laws purport to seek to protect; and

WHEREAS, the Township further recognizes that immigration law and enforcement are federal functions under the United States Constitution and believes that legislation restricting federal-state cooperation in this area is subject to constitutional challenge under the Supremacy Clause; and

WHEREAS, the Township is concerned that enactments designed to restrict cooperation or disclosure may invite costly litigation, create preemption disputes, undermine consistent enforcement practices, and expose municipalities and their officers to legal uncertainty, financial burdens, and operational difficulties, observing that the federal government has already sued New Jersey twice since March 2026; and

WHEREAS, the Township is concerned that requiring officers to reveal facial identity without adequate operational exceptions may increase the risk of retaliation, harassment, doxxing, targeting of officers and their families, and compromise of undercover, tactical, or other security-sensitive functions; and

WHEREAS, the Township finds that limiting the collection or sharing of personal information may impede legitimate law enforcement investigations, interagency coordination, and emergency response efforts, including efforts involving individuals who may pose threats to public safety; and

WHEREAS, the Township therefore wishes to formally express its opposition to the foregoing enactments and to urge the Legislature and the Governor to repeal them; and

WHEREAS, New Jersey's sanctuary policies have directly resulted in two avoidable lawsuits initiated by the federal government challenging unconstitutional policies as well as violent unrest and disorder outside of Newark's Delaney Hall, a U.S. Immigration and Customs Enforcement's ("ICE") detention facility.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey

that the Township hereby formally opposes the recently enacted laws identified above.

BE IT FURTHER RESOLVED that the Township finds that these laws, individually and collectively, raise substantial concerns regarding public safety, law enforcement officer safety, effective federal-state and interagency cooperation, and the ability of local law enforcement to carry out its responsibilities in a clear, coordinated and lawful manner.

BE IT FURTHER RESOLVED that as a matter of policy and legal concern, that state measures restricting cooperation, identification practices, or information-sharing in this area may create practical conflicts with legitimate law enforcement objectives, burden municipal operations, and contribute to costly and divisive disputes concerning the limits of state authority, federal supremacy in immigration matters, and preemption principles under the United States Constitution.

BE IT FURTHER RESOLVED that the Township urges the Governor and the Legislature repeal the laws identified above and to take such prompt executive and legislative action as may be necessary to eliminate the risks these laws may pose to officer safety, law enforcement effectiveness and sound intergovernmental relations.

BE IT FURTHER RESOLVED that the Township urges that any future legislation in this area respect the supremacy of the federal government under the United States Constitution in matters of immigration policy and enforcement, and include clear protections for officer safety and operations, workable standards for interagency coordination, and provisions that preserve the ability of law enforcement to respond effectively to threats to the public.

BE IT FURTHER RESOLVED that the Township encourages state, county, and local law enforcement, to the fullest extent permitted by law, to cooperate with other law enforcement agencies in securing our community against threats to public safety as well as assist federal authorities in safeguarding government installations located in the Garden State.

BE IT FURTHER RESOLVED that the Township Clerk is hereby directed to transmit a certified copy of this Resolution to the Governor, the President of the Senate, the Speaker of the General Assembly, the Township's representatives in the Legislature, the Attorney General, the State League of Municipalities, the Association of Counties, the United States Attorney for the District of New Jersey, and such other public officials and organizations as may be appropriate.


